I understand that bicycling involves a risk of injury, that injuries are a common and ordinary occurrence of the sport, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist.

I accept responsibility for the condition of my bicycle and agree to abide by all rules of the Tour, especially the wearing of a helmet at all times while bicycling on the tour.

I agree, for myself and on the behalf of my heirs, assigns, personal representatives and next of kin, as a consideration of, and in consideration for, being permitted to participate in the Tour, to freely and expressly assume and accept any and all risks, known and unknown, of injury or death to the rider, or property loss or damage, including injury, death, loss, or damage attributable to the negligence of PARKS & TRAILS NEW YORK, IN MOTION EVENTS, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event.
