

## Introduction

The Canalway Trail system is one of New York State's premier outdoor destinations. The trail gives New Yorkers in more than 200 communities a dedicated place to walk, jog, and bike right from their doorsteps as well as drawing visitors from around the world. In 2020, the Canalway Trail was incorporated into New York's flagship Empire State Trail, part of a 750-mile trail network stretching from New York City north to the Canadian border and from Albany west to Buffalo.

Since 2005, Parks & Trails New York (PTNY) and the New York State Canal Corporation (NYSCC) have monitored and measured the trail's popularity by conducting annual Canalway Trail counts. The count process utilizes electronic trail counters installed at selected locations. The counters use infrared pyroelectric technology to count people passing within range of the sensor by detecting body temperature.

In 2023, PTNY counted trail use at fifteen locations along the Erie and Champlain Canalway Trails. These counts were augmented by manual counts conducted by volunteers at eight discrete locations within four communities along the Erie Canalway Trail. Additional electronic counts were also performed by three partners. The Genesee Transportation Council counted visitation at six locations and the City of Rome counted visitation at one location along the Erie Canalway Trail, with the Hudson River Valley Greenway counting trail use at one location on the Champlain Canalway Trail.

The counts analyzed in this Who's on the Trail report provide a snapshot of the immense popularity of the Canalway Trail. PTNY estimates that the Canalway Trail system receives roughly 3.947 million visits per year, including 3.835 million visits to the Erie Canalway Trail and 112,000 visits to the Champlain Canalway Trail. These estimates are based on longitudinal count data from electronic counters installed at 33 locations along the trail over the past five years.

Thanks to the Erie Canalway National Heritage Corridor, supporting data collected from 2023's Canalway Challenge finishers is also included to provide additional context to the numerical count data. Challenge finishers include those that complete mileage goals ranging from 1 mile to the full 360-mile trail. Data on Canalway Challenge participants provides information about the demographic composition of trail users as well as trip characteristics. These details provide insights about where visitors are coming from, what types of sites and overnight accommodations are being visited, and how these trail users are impacting the local economies of trailside communities.

Data documenting the popularity of the Canalway Trail system has underscored the significant value of millions of dollars in public investment for maintenance and construction across the state over the past two decades and is helping to guide future investments to optimize utilization and impact.

## **2023 Counts Overview**

Electronic counters recorded trail usage at fourteen locations along the Erie Canalway Trail and at two locations along the Champlain Canalway Trail during 2023. At four locations – Medina, Brockport, Pittsford and Kingsbury - counters were installed at different times in 2022 and remained installed into May 2023, when they were removed. Counters were installed at seven new locations in summer 2023 – Lockport, Newark, Jordan, Rome, Utica, Fort Plain, and Jordan. In fall 2023, the NYS Canal Corporation purchased five additional counters. These five counters were installed in October 2023 at four locations – Medina, Albion, Greece, Ilion, and Schuylerville. Eleven counters remain installed into 2024, with the exception being the counter in Jordan, which was removed in early 2024 due to malfunctioning equipment.

## **Trail Count Summary & Profiles**

Data on the following pages summarizes trail use recorded at each of the count sites for 2023, including data available from 2022 where appropriate. Each page provides contextual information on timeframe, duration, and location of counter installation. The location maps show trail surface type (solid blue is paved, dashed blue is stone dust, and orange is on road), and provide additional geographic context for each location.

Count profiles show estimated annual and monthly uses, as well as daily average use by month and daily average use during summer (June 21st through September 20th). Estimated annual use was calculated using National Bicycle and Pedestrian Demonstration Project extrapolation criteria (see our accompanying <a href="Who's on the Trail: Methodology">Who's on the Trail: Methodology</a> report for more information on how extrapolation calculations are conducted).

Due to the limited duration for which they were installed, data from four locations at which counters were installed in fall 2023—Albion, Greece, Ilion, and Schuylerville—is not shown in the table below as full-year extrapolations could not be confidently calculated. Profiles of these locations, however, are included in the following pages. More information on these count locations—and all locations that remain installed into 2024—will be included in 2025's report summarizing 2024 trail use.

## Lockport

#### **Niagara County**

Installed May 16, 2023 - December 31, 2023


The counter was installed just east of the Mill Street trail crossing on the east side of Lockport as part of the 2023 Empire State Trail Town program. This stone dust surface section of trail is proximate to the west end of a 90-mile continuous stretch of off-road trail running from Lockport east past Rochester to Buffalo which features few, minor on-road segments.



Installed July 11, 2022 - May 11, 2023 and October 24, 2023 - December 31, 2023





## **Albion**

#### **Orleans County**

Installed October 24, 2023 to December 31, 2023

The counter was installed just west of Main Street. East of this point, the Main Street Lift Bridge (closed for reconstruction in 2023) crosses the canal. The trail surface through this section is primarily stone dust. The surrounding area is rural, with the village located about halfway between the urban centers of Buffalo and Rochester. The counter was installed in this location in October 2023, so sufficient data has not yet been gathered to accurately estimate full-year trail use.





## **Brockport**

#### **Monroe County**


Installed May 25, 2022 - May 9, 2023


The counter was installed just east of the Park Avenue Lift Bridge as part of the Empire State Trail Town program in 2022. With the closure of Brockport's Main Street Lift Bridge in 2023 for reconstruction, the Park Avenue Bridge became one of the primary connections between the trail and Brockport's business district. The surface of the trail is mostly stone dust through the entire section save a short, paved segment to the west of the installed counter, between Park Avenue and Main Street.

## **Greece**

#### **Monroe County**

Installed October 24, 2023 - December 31, 2023

The counter was installed on one of the approach ramps leading from the trail on the canal's south side to Long Pond Road, which carries the trail over the canal to the north side where it continues to the west. The trail in this section is paved from Long Pond Road east into the city of Rochester. As there are two usable approaches from the trail to Long Pond Road, the counter is likely only capturing a portion of total trail users at this location. The counter was installed in this location in October 2023, so sufficient data has not yet been gathered to accurately estimate full-year trail use.



Installed May 25, 2022 - May 11, 2023





#### **Wayne County**




## Rome

#### **Oneida County**

Installed at Old Erie Canal SHP May 10, 2023 - December 31, 2023; Installed at Martin Street July 11, 2023 - December 31, 2023

Two counters were installed in Rome as part of the Empire State Trail Town program in 2023. The first counter was installed at the eastern end of Old Erie Canal State Historic Park, on the west side of Rome. Old Erie Canal State Historic Park features a stone dust surface for most of its 32 miles between Syracuse and Rome. The trail from the counter's location east into the city of Rome was in poor condition throughout 2023, but is slated for resurfacing in 2024. The second counter was purchased and installed by the city of Rome in July 2023 along Martin Street on the east side of the city. The trail in this section is paved and connects to a mostly continuous, off-road, stone dust stretch between Rome's south side and the City of Utica.

Installed May 10, 2023 - December 31, 2023





## Ilion

#### **Herkimer County**

Installed October 23, 2023 - December 31, 2023

This counter was installed just east of Ilion Marina, located off Central Avenue/NYS Route 51 in the Village of Ilion. The paved trail in this location was constructed in 2020 as part of the Empire State Trail project, and is approximately one mile from the western end of a 70-mile continuous stretch of off-road trail with only a few minor on-road segments that runs from Frankfort east to Schenectady. The counter was installed in this location in October 2023, so sufficient data has not yet been gathered to accurately estimate full-year trail use.





Installed August 9, 2023 to December 31, 2023


The counter was installed just north of Corning Preserve in the city of Albany, near the eastern terminus of the Erie Canalway Trail. The trail in this location is paved and runs north along the Hudson River to 4th Avenue in Watervliet. The trail was resurfaced with asphalt in 2021. Traveling south, the trail runs through Corning Preserve, Albany's waterfront park, and continues as part of the Empire State Trail across the river to Rensselaer and the Albany-Hudson Electric Trail, leading south to New York City.

The counter was installed along the Champlain Canalway Trail between Fort Hardy Park and Hudson Crossing Park in Schuylerville. The trail in this location has a stone dust surface, and is part of a roughly one-mile-long stretch of off-road trail bounded on either end by lengthy on-road segments. The counter was installed in this location in November 2023, so sufficient data has not yet been gathered to accurately estimate full-year trail use.





## **Partner Counts**

PTNY partner organizations conducted counts at thirteen additional locations along the Canalway Trail System in 2023. The Genesee Transportation Council (GTC) performed counts for two- to four-month stretches at a total of six locations: Gates; Rochester; and a cluster of four locations in Fairport. The Hudson River Valley Greenway (HRVG) installed a counter for one year in Halfmoon along the Champlain Canalway Trail. Warren County Planning conducted trail counts at six locations along the Champlain Canalway Trail and Feeder Canal Trail. PTNY conducted analysis on these additional count sites.



### **Genesee Transportation Council**

#### **Monroe County**

As the Metropolitan Planning Organization for the Rochester area, the Genesee Transportation Council performs counts on trails and other bicycle and pedestrian facilities throughout their service area. As part of this work, counters were installed along the trail at four locations in the Village of Fairport from June 2023 through November 2023 (actual count periods for each of the four locations varied). Counters were also installed at the junction with the Lehigh Valley in Rochester, and in the town of Brighton at the I-390 bridge, from October through November 2023.

### **Hudson River Valley Greenway**

#### **Saratoga County**

The Hudson River Valley Greenway, a New York State Agency, directly supervised the completion of the Empire State Trail. Since the trail's completion, HRVG has counted use at various locations along the full north-south leg of the Empire State Trail, which runs from New York City to Rouses Point. In 2023, HRVG counted data at one location along the Champlain Canalway Trail. This counter was installed in the town of Halfmoon in November 2022 and recorded data for a full year. The counter was located along a stone dust section of trail in a suburban area close to the more heavily populated centers in Albany, Troy, and Saratoga County.

#### **Warren County**

#### **Warren & Washington County**

In June 2023, the NYS Department of Transportation conducted trail counts for the Warren County Planning Department as part of a large-scale trail improvement plan. Counts were conducted using a video-based counting system at six locations, including two along the Champlain Canalway Trail between Fort Edward and Kingsbury, and four along the Feeder Canal Trail in Hudson Falls and Glens Falls. Counts were also conducted along the Warren County Bikeway, but are not included in this report as the trail is not considered part of the Canalway Trail system. At each location, trail use was counted from 7:00 AM to 7:00 PM for the week of June 15 to June 21, 2023. The data also provide a breakdown by direction of travel along the trail and the mode of travel (pedestrian or bicycle).

## **Manual Counts**

In addition to electronic counters, PTNY recruited volunteers to collect trail use data manually. Manual counts were primarily conducted by volunteers associated with the Empire State Trail Town program, with additional manual counts conducted in the town of Perinton. Manual counts offer the opportunity to collect more information on the types of visitors using the trail at each location. In addition, manual counts were intended to provide insight into the accuracy of counts conducted by electronic counters, but insufficient data was collected to yield any reliable conclusions. Manual counts followed the counting methodology inspired by the NBPD count methodology included in the Who's on the Trail 2023: Methodology document.

## **Lockport**

#### State Road Trailhead and Mill Street intersection

Volunteers counted trail use at two locations in the City of Lockport. Counts were conducted at the trailhead off State Road on the west side of the community, along a paved trail heading west towards Tonawanda and Buffalo, and at the location where the counter was installed at the Mill Street bridge (see page 6).





## **Perinton**

#### **East end of Perinton Park**

Volunteers counted trail use at the east end of Perinton Park in the town of Perinton, a suburban town located to the east of Rochester and west of the village of Fairport. The trail through this area is paved and is a popular recreational resource for locals and visitors alike.









#### Newark

#### **Harder Park and T. Spencer Knight Park**

Volunteers counted trail use at two locations in the Village of Newark. Counts were conducted at Harder Park, where the counter was installed (see page 12), and at T. Spencer Knight Park in downtown Newark. The trail is paved and travels diagonally through Knight Park to the newly rebranded Newark Welcome Center.







#### Rome

#### Old Erie Canal State Historic Park, West Dominick Street, and Martin Street

Volunteers counted trail users at three locations in the City of Rome. Counts were conducted at the counter locations in Old Erie Canal State Historic Park and along Martin Street (see page 14). Manual counts were also conducted along an on-road segment of the trail on West Dominick Street between Madison Street and George Street. Through this section, a sidewalk serves as the Erie Canalway Trail for pedestrians, whereas cyclists must ride in the road.





## Annual Trail Use Estimate: 3.95 million

Since 2019, PTNY or its partners have conducted long-term electronic trail counts at 33 locations along the Canalway Trail. Each of these count sites has produced an annual trail use estimate; taken together, the sites recorded a total of 1,812,731 visits per year across the state. The site data affirm a correlation between trail use and the population density of the surrounding area, which can be used to estimate trail uses at locations where counts have not yet been performed.

Using figures from these additional locations, an estimated annual Canalway Trail visitation figure of 3,947,000 can be calculated, including 3,835,000 visits along the Erie Canalway Trail and 112,000 along the Champlain Canalway Trail. This figure is a rough estimate, and does not represent the use for any specific year. Rather, the figure is an estimated average use figure for annual visitation based on the last five years of data. 
## **Canalway Challenge Finisher Statistics**

Since 2019, the Erie Canalway National Heritage Corridor has encouraged New Yorkers and visitors to explore the Canalway Trail and state Canal Waterways through the Canalway Challenge. Challenge options include 1, 15, 90, 180, and 360-mile goals. To complete the 360 mile "end-to-end" challenge, the participant must walk, ride, or paddle their miles in each region. In 2023, over 450 challenges were completed, with 81% of finishers submitting a "finisher survey." This survey—which gathered information on where finishers are from, what types of destinations they visited, if they stayed overnight and where, and how much they spent while completing their challenge—augments the numerical data included in the rest of this report, providing a more comprehensive picture of who is using the trail and how.

### **Origins**


Canalway Challenge finishers hailed from thirty U.S. states and two Canadian provinces, with 27% of finishers coming from outside of New York State.


#### **Attractions & Sites Visited**

Canal Towns and Cities were cited as the most visited destinations, followed by canal structures and vessels like locks and historic canal boats. Next were restaurants and bars. Visiting local eateries is a very popular way to add a destination to an out-and-back trip on the trail, and for long-distance travelers these establishments are essential places to refuel after a long day out on the trail. Museums and historic sites were also popular attractions, demonstrating that trail travelers place importance on learning about the history and heritage of the waterway and region.




### **Nights Stayed Over**

Those completing longer mileage challenges stayed overnight more evenings while working toward their goal. End-to-enders spent the greatest number of nights on the trail, averaging just under seven overnight stays. Other challenges did not require cross-region exploration, and thus reflected fewer overnight stays.




#### **Accommodations**

About half of the finishers who completed the survey indicated they stayed over at least one night while completing their challenge. Of those who stayed overnight, about three quarters chose to stay in a hotel or motel for at least one of their nights. Camping at a lock site and at campgrounds were the next most popular ways to spend the night, showcasing the adventurous nature of trail travelers. Bed & Breakfasts were as popular as camping facilities.



## **Average Spending**

On average, challenge finishers spent \$420 while completing their challenge. As might be expected, challengers who took on the most miles spent the most money, with end-to-enders spending the most during the course of completing their challenge.



## Conclusion

The 2023 Who's on the Trail report is the 18th edition of this report. Once again, trail counts and analysis reveal the statewide popularity of the Canalway Trail System, totaling an estimated 3.9 million visits per year. Investments to the trail including gap closures and resurfacing projects continue to drive visitation. Used heavily by both walkers and bicyclists, and enjoyed by locals and visitors alike, the trail system is clearly a major recreational asset for communities across the canal corridor. The strong causal relationship between trail improvement and resultant economic value underscore the need to continue promotion, investment and maintenance.

The 2024 Who's on the Trail report will include some significant changes. Additional counters acquired during 2023 will provide data for additional sites, and counters installed in early 2023 will be moved to new sites for 2024. PTNY continues to work with metropolitan planning organizations to assess local trail use, following best practices from Rochester's Genesee Transportation Council.

Two major changes are expected for 2024. First, thanks to an upcoming joint effort with the NYS Office of Parks, Recreation and Historic Preservation, PTNY will work toward updating NBPD Extrapolation Factors, which provide the basis of trail use estimates used throughout this report. Current NBPD Factors are nearly 15 years old. While they are the best resource currently available, they are increasingly inconsistent with observed data collected around the state. Updated, New York State-specific extrapolation factors will better align trail use estimates and observed data. Second, PTNY will use groundbreaking AI technology through Placer.ai, a web-based location data analytics company, to provide a comprehensive analysis of the overall use of the Canalway Trail. The Placer.ai datasets will also provide greater detail about trail users, including demographic and other social characteristics. The update of NBPD factors coupled with Placer.ai data will provide a greater and more accurate understanding of Canalway Trail use, the benefits the trail system provides local residents, and the degree to which trail users provide an economic benefit to canal corridor communities. Continuing to expand the availability of data for the Canalway Trail will provide trail managers with the information needed to spur continued growth in usage and drive improvements that continually increase the quality of experience for all trail users.
